Data is held by the Board of Directors and managed on their behalf by the office manager, J Willshire, at the Fishing Lodge, Hallington Reservoir, Colwell, Hexham NE46 4TP

Data is held for membership purposes, to have a record of all members, (including Directors, Honorary members and Complimentary members) their email addresses, home addresses and telephone numbers (landline and mobile), their occupation or former occupation and date of birth.

Data is held to inform members of club events, rule changes and information updates. It is also held to assist the Directors in the planning of club activities and delivery of the Clubs high quality offer to the membership.

Members' data is not shared with third parties (including other club members).

Members' data is held for the duration of membership of the club, and is updated annually when members are invited to apply to rejoin the club. If membership ceases, either by cancellation, expiry or expulsion, members' data is removed within 6 months.

Membership information is protected by the application forms being kept securely at the Fishing Lodge locked office. Data is held on the Clubs computer at the Fishing Lodge and by individual Directors on their personal computers at their home addresses.
